

To keep patients, visitors, and staff safe and healthy, NVRH is taking additional measures to prevent the spread of infection within the hospital, medical offices, and the community.

**All Support People and Visitors must:**

1. **SHOW PROOF OF VACCINATION** (EXCEPT IN RARE EXCEPTIONS LISTED BELOW)
2. **BE SCREENED FOR COVID SIGNS AND SYMPTOMS, AND EXPOSURE**, PER HOSPITAL PROTOCOL
3. **WEAR A SURGICAL/PROCEDURAL OR N95 MASK AT ALL TIMES**. MASK MUST FULLY COVER NOSE AND MOUTH.
4. **REMAIN IN THE PATIENT’S ROOM FOR THE DURATION OF THE VISIT. ^NO CONGREGATING IN WAITING AREAS, LOBBIES, HALLWAYS, OR THE CAFETERIA BEFORE, AFTER, OR BETWEEN VISITS.**
5. **USE ONLY VISITOR DESIGNATED BATHROOMS.**
6. **COMPLY WITH RESTRICTIONS SET BY THE HEALTHCARE PROVIDER BASED ON VOLUME AND CAPACITY.**

Inpatient: Adult (Medical Surgical Unit and ICU)	2 fully vaccinated visitors at a time (12 years of age and up)	1pm-6pm
Inpatient: End of Life	2 consistent healthy support people (12 years of age and up)	24 hours
	Fully vaccinated people (12 years of age and up) are able to visit during visiting hours. There may be no more than 2 people in the room at a time. <i>Note: This may mean that one or both of the support people need to leave to allow others to visit<sup>^</sup>.</i>	1pm-6pm
Inpatient: Pediatric Patients	2 healthy parents or guardians	24 hours
Inpatient: Birth Center	1 healthy support person and 1 fully vaccinated support person (or 2 fully vaccinated support people) during labor and delivery	24 hours
	2 fully vaccinated visitors at a time (12 years of age and up)	1pm-6pm
Emergency Department	<b>Adults: Due to current community conditions - no visitors allowed (exception - 1 healthy support person for pts requiring special assistance)</b>	24 hours
	Pediatric Patients: 2 healthy parents or guardians	24 hours
Outpatient Surgery	Adults: 1 fully vaccinated support person to escort the patient before and after the surgery/procedure only.	Business hours
	Pediatric Patients: 2 healthy parents or guardians	Business hours
Outpatient: Clinics and Medical Offices, Diagnostic Imaging, Laboratory, and Respiratory Services (including	Adults: 1 consistent fully vaccinated visitor (or one healthy support person for pts requiring special assistance)	Business hours
	OB Ultrasounds: 1 fully vaccinated support person	Business hours
	Pediatric Patients: 2 healthy parents or guardians	Business hours
Outpatient: Infusion Services	Due to space limits, no visitors allowed for infusion services on second floor.	N/A

*\*fully vaccinated means 14 days out from second dose of Pfizer or Moderna, or 14 days out from single dose of Johnson and Johnson: visitor must show proof of vaccination*

*\*healthy means those people (vaccinated or unvaccinated) who passed the Covid screening, per hospital protocol*

**No VISITORS WILL BE PERMITTED FOR PATIENTS WITH A POSITIVE COVID TEST, OR WITH A PENDING COVID TEST AND WITH COVID SYMPTOMS AND RISKS. (EXCEPTION: FOR SUPPORT PERSON FOR BIRTH CENTER AND PEDIATRIC PATIENTS.)**

**Restricted Entrances:** All NVRH buildings and clinics will be restricted and everyone who enters will be screened (for fever and symptoms) prior to entering any building.
