



Connecting with family and friends is an important part of the healing process.
NVRH is committed to helping this connection happen.

To keep patients, visitors, and staff safe and healthy, we ask that visitors:

1. Do not visit if you have any of these symptoms: fever, chills, cough, sore throat, runny or congested nose, or new shortness of breath.
2. Do not gather in the hallways within patient areas, rather, use designated waiting rooms.
3. Comply with restrictions set by the healthcare provider based on volume and capacity.

No visitors will be permitted for patients with a positive COVID test, or with a pending COVID test and COVID symptoms and risks. (Exceptions: End of Life, support person for Birth Center and Pediatric Patients.)

Inpatient: Adult (Medical Surgical Unit, ICU)	2 healthy visitors at a time (pediatric visitation is limited to healthy children age 5 and up - no pediatric visitors will be allowed for patients on respiratory precautions) <i>Note: may be limited by the healthcare provider based on needs of patient</i>	7 a.m.-8 p.m.
Inpatient: Pediatric Patients	2 consistent healthy parents or guardians	24 hours
End of Life***	4 healthy support people at a time	24 hours
Birth Center	2 consistent healthy support people during labor and delivery	24 hours
	2 healthy visitors at a time (pediatric visitation is limited to healthy siblings - no pediatric visitors will be allowed for patients on respiratory precautions) <i>Note: the primary support person is not considered a visitor and may remain in the room/visitation may be limited by the healthcare provider based on needs of patient</i>	7 a.m.-8 p.m.
Emergency Department	Adults: 1 consistent healthy support person (>18yo age) <i>Note: may be limited by the healthcare provider based on ED volume and capacity</i>	24 hours
	Pediatric Patients: 2 healthy parents or guardians	24 hours
Outpatient Surgery	Adults: 1 healthy support person (>18yo age)	Business hours
	Pediatric Patients: 2 healthy parents or guardians	Business hours
Clinics and Medical Offices	Adults and Pediatric Patients: 2 healthy support people	Business hours
Diagnostic Imaging, Laboratory, and Respiratory Services	Adults: 1 healthy support person	Business hours

Infusion Services	Due to space limits, no visitors allowed for infusion services on second floor.	N/A

***** Visitors of COVID+ or potentially positive patients who are receiving end of life or "comfort measure" care:**

- Visitors must wear full personal protective equipment, to include mask, gown, gloves, and eye protection throughout their visit.
- Visitors must stay in the patient's room for the entire visit. They may not visit the Cafe, Gift Shop, billing/finance, or any other public locations within NVRH during or after their visit.
- Visitors assume the risk of contracting COVID if visiting a COVID+ patient.
